Notice of Election and Nominations
for CPRIOA Board of Directors
Monday, March 8th – Monday, March 15th, 2021

The CPRIOA Nominating Committee has set the dates for the election of the Board of Directors to be held from **Monday, March 8th- Monday, March 15th, 2021**. Election results will be published to the membership on or before March 19, 2021.

The Nominating Committee has nominated the candidates named below for election to the Board of Directors as is provided in the CPRIOA Bylaws that are [linked to this notice](#). Pursuant to the Bylaws, the Board of Directors is elected by the membership, and the elected board selects the Association officers. The Proposed Bylaws provide for a Board of Directors of up to seven (7) board members, and seven (7) candidates have been nominated by the Nominating Committee.

Nominations are now open for other members to place their names for consideration for a Board of Directors position. If any member would like to seek election to the Board, or make any additional nominations, please email jen.foreman@aafd.org your nomination and one seconding nomination (self-nominations require two seconding nominations) to the AAFD no later than 5:00pm, on Friday, March 5th, 2021. You must be a member in good standing to vote and participate in the chapter election or to serve as an officer or board member. Not a member? Click <https://membership.aafd.org/> to join.

Your ballots will be emailed and sent by text (if we have an SMS phone number on record) on or before Monday, March 8th, 2021. You will have until Midnight, Monday, March 15th, 2021 to cast your ballot for your vote to count. The election will be conducted electronically by ElectionBuddy.com, monitored and tabulated by the AAFD. If there are no contested board positions (more candidates than open board positions) each member can either simply vote for the entire slate or will have one (1) vote for up to seven (7) candidates. If there are more than seven (7) nominated candidates, each member will have 1 vote for their first store, and a half vote for each additional store owned.
